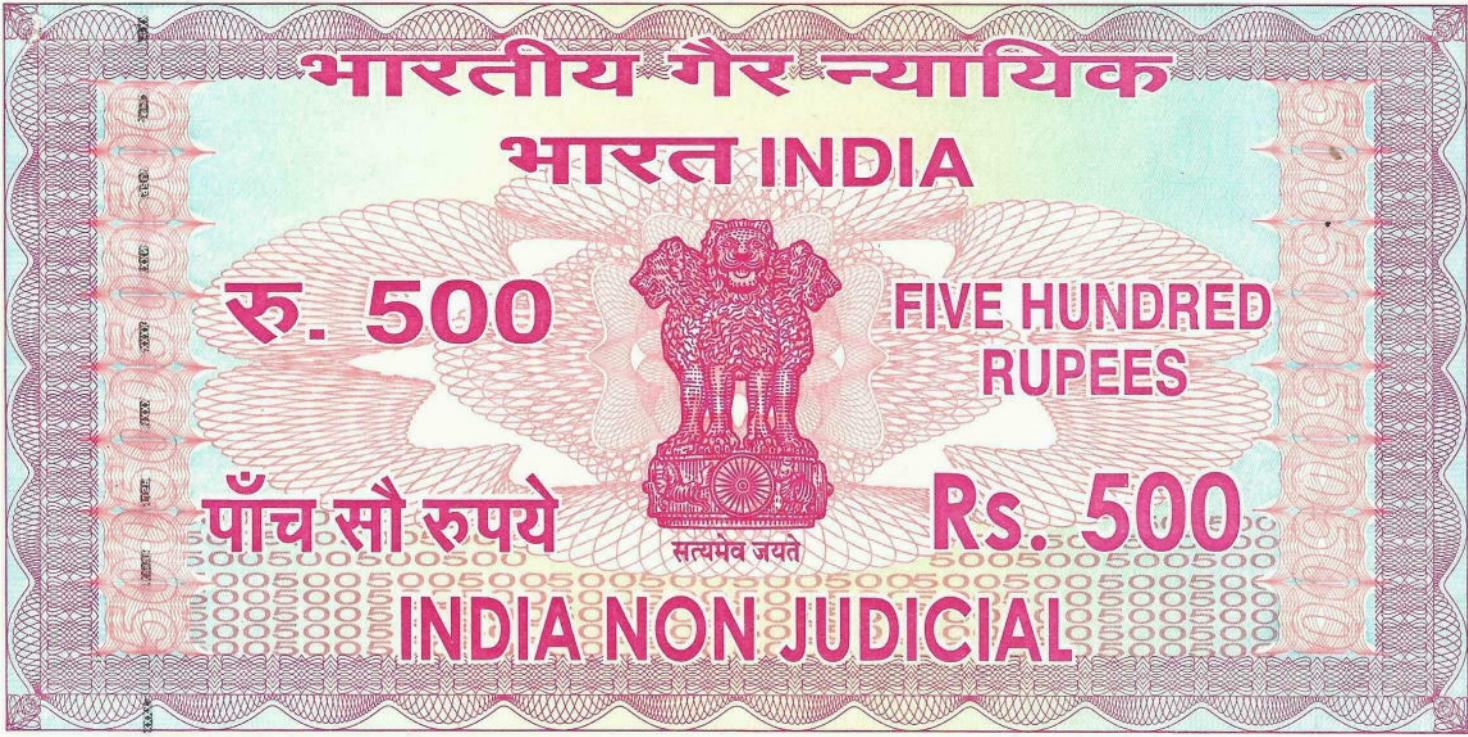

Whereas the founder of the Trust has been cherishing to create a Trust for the purposes of providing basic education and research among all the people irrespective of caste, creed, colour and religion.

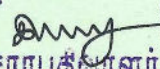
And whereas the Founder of the Trust has already set apart and assigned in Trust a sum of **Rs.1,000/- (Rupees one Thousand only)** and handed over the same to the Trustee hereinafter appearing to be held as the **corpus of the Trust on the following terms, namely:-**

NAME OF THE TRUST

1. The name of the Trust shall be “ **SURIAMURTHI SURYAGANDHI DREAM EDUCATIONAL TRUST- MAMPATTI** ” and shall herein after be referred to as the Trust and its office shall be for the present at Door No:447, Ganesapuram, Mampatti, Eriyur Post, Singampunari Taluk, Sivagangai District, TamilNadu, India, Pincode:630 566 (**a rental buildings**) and at such other place or places within India as may be decided by the Trustees from time to time.
2. The founder declared as follows **S.PORKODI** shall be managing Trustees of the trust during their lifetime or till such time as they choose.

The following persons are nominated as Trustees.

3. OBJECT OF THE TRUST

The object of the Trust are as under:

- a) Spreading of Education and culture
- b) Providing for research in all fields of science, arts, technology and such other fields including yoga, therapies etc
- c) Providing for improvement of quality of human life
- d) Advancement of any object of general public utility.

Without prejudice to the generality of the foregoing the objects of the trust shall include the following:

- Establishment, acquisition, maintenance and/or management or support of schools, colleges, vidyapiths, training institutue, balmandirs, study centers, Universities, Planertarium and other institutions for imparting education and training to students.
- To provide for school education, including vocational education, work experience, etc.
- To provide for collegiate education, including pre-degree courses, integrated courses, doctoral programs, etc. in various fields such as Arts, Science, Commerce, Special Sciences, humanities. Social Work Education, Integrated Rural development, Yogic practices including meditation, pranayam, Kriyas and such other fields.
- To provide continuing education, non formal education in all fields, careers and professions.
- To provide Technical Education programs, Medical Science Programs in all branches and specialities of the above.
- To provide Industrial education and training at all levels and during vacations in various skills, arts and crafts as well as various trades including all other branches of education, skills and knowledge.
- To provide ample opportunities of integrating the education with the needs of socio-economic development. Social service, rural development, urban development and such other new disciplines and specialities.
- To provide teacher training programs and courses for general teaching, collegiate teaching, teaching in the fields of Yoga and allied areas and for technical institutions.
- To provide job oriented education, training and work experience programs and such education and training so as to develop self employment and

- To provide, maintain, develop, improve and extend the necessary facilities in various institutions under the Trust for the purpose of education, training, research and development in the various fields such as Arts, Science, Engineering, Medicine, Technology, Architecture, Management, Yoga and its allied fields, and any other new disciplines.
- To accept autonomous status to any of the institution as and when the University Grants Commission and/or any other competent authority accord.
- To provide for dissemination of literacy, cultural and scientific knowledge through publication of magazines, periodicals, books, pamphlets and through electronic media and to establish necessary facilities for printing, publication and production.
- To assist students who are poor and/or who are deserving by way of free scholarships, free boarding and lodging, free clothing, books, instruments and such other things required.
- To establish, maintain, improve and extend the hostel facilities and boarding places and for the benefit of students.
- Establishment and support of professorships, fellowships, lectureship, scholarship, and prizes at schools, colleges or other educational institutions.
- Grant of endowments at Universities, Research Institutions and other educational and scientific institutions (whether now existing or hereinafter established) for spreading of education and knowledge in all or any branches of knowledge.
- Assisting in the promotion of research and development in various fields and/or for undertaking, prosecuting and encouraging higher education and research bacteriology, medical sciences, Yoga, Meditation and other related fields. Horticulture, agriculture, or any other branch/or branches of modern applied science in the widest and most comprehensive sense.
- Assisting students to pursue their academic, professional and other studies by providing scholarships, hostel facilities, supply of books and other requirements.
- To promote music, drama, dance and other Fine Arts and/or to establish institution for propagation and implementation, training in these fields and to render assistance to students in the foregoing fields.

- To carry out all such acts, deeds and things which are incidental or necessary for the promotion of the aforementioned objects, without reference to caste, creed or religion.

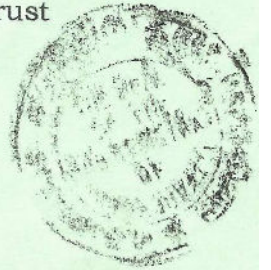

c) After the life of the **MANAGING TRUSTEES S.PORKODI**, his legal heir shall be the **Managing Trustee of the Trust**.

5.POWERS OF THE TRUSTEES

- The Managing Trustees shall hold the properties of the Trust for the objects stated herein.
- The Managing Trustees is authorized to open account or accounts with any bank and operate the said accounts.
- The Managing Trustees is authorized to borrow money for the purpose of the Trust with or without security from banks, financial institutions or others and also have the power to offer as security any immovable or movable property or other funds or properties of the Trust.
- The Managing Trustees has the power to employ persons to carry out the objects of the trust and also the power to dismiss of dispense with services of such persons.
- The Managing Trustees is authorized to acquire land, building, or other immovable property for the Trust with the funds of the Trust and for the objects of the Trust

- f) The Managing Trustees will have power in General to acquire all things and do all acts necessary to carry out the objects of the Trust.
- g) The Trustees shall not carry on any business with the Funds of the Trust other than a business which is carried on in the course of actual carrying out of primacy purposes of the Trust as per the provisions of the Income Tax Act.
- h) The Managing Trustees is authorized to sell, lease, mortgage, or otherwise deal with any property of the Trust (both movable & immovable) as may be found expedient from time to time. No part of Funds or income of the Trust shall be taken directly or Indirectly for the benefits of the Trustees.
- i) Trustees shall not be entitled to any remuneration but entitled to receive out of pocket expenses incurred by them in the course of discharging their responsibilities as Trustees.
- j) The Trustees may at any time receive any voluntary contribution with or without invitation either from the Trustees or from any one or more of them or from any other person or persons by way of donation, legacy or otherwise which will from part of the corpus.
- k) The funds of the Trust shall be invested in 'Specified Investments' as per the provisions of Sec.13(1)(d) read with sec.11(5) of the Income Tax Act, 1961.
- l) Donating contributing funds to such institutions which are recognized under section 80G of the Income-tax Act, 1961 as amended from time to time.
- m) The trustees are authorized to frame rules for the proper conduct of the Trust, but any such rule shall not be against the objects of the Trust or any other conditions of the Trust deed
- n) The Trustees shall maintain proper books of account and the same shall be audited annually by a chartered Accountant appointed by Trustees for the purpose. The accounting year of the Trust shall be from 1st April to 31st March.

- o) Every power, authority, discretion conferred upon the Trustees shall be exercised or signified either by some instrument in writing to be signed by all trustees or such of them, as may so present or by the resolution of the Trustees or such of them, as may be present there and vote at any meeting of the Trustees
- p) A minute book shall be maintained by the Trustees and all proceedings of the Trustees shall be entered in the Minute book and shall be signed by the Trustees.

6. TRUST FUND

I) The Managing Trustees hereby declares that the Trustees shall and will stand possessed of the said sum upon trust and any other capital moneys and donations which the Trustees may receive from time to time from friends and relatives to augment the Funds of the Trust.

II) The Trust may acquire or receive movable and immovable properties by way of donations, gifts, entrustments, purchases by grant or by any other mode and may sell, dispose exchange such properties to be held solely and exclusively for the objects of the Trust.

III) The Funds of the Trust shall not be applied for any purpose other than the objects of the Trust.

7. ACCOUNTS

a) The Accounts of the Trust shall be closed every year on the 31st day of March and the accounts of the Trust shall be examined and the correctness of the accounts shall be got certified by a chartered Accountant annually.

b) The Trustees shall be indemnified against any expense or losses incurred or suffered or any payments made by them in the administration of the Trust and such expenses and losses and payments shall be borne by the Trust

8. AMENDMENTS

The Managing Trustees alone shall have powers from time to time to make and to alter or amend the rules and regulations that was made with regard to the conduct of the Trust and all matters in respect of which any power or duty is thereof vested in him as he may think proper.
